To Participants and Spectators

The Flat-Coated Retriever Society of Canada welcomes you to our licensed Working Certificate Tests. Your support is truly appreciated! While on the test grounds please observe the following:

- Join the excitement enter your dogs in Saturday's Scurry! Fun and great prizes!! Starts at noon, Saturday.
- While dogs are under judgment, please refrain from loud talking and excessive motion.
- Please do not applaud until the competing dog has finished working and been released by the judges.
- Spectators must remain in the area designated by the Marshal.
- Participants should check in with the Marshal and proceed to the designated holding blinds as directed by the Marshal.
- If your bitch is in season, check in with the Marshal first thing in the morning; the running order will be adjusted to have bitches in season run last.
- Please do not bring visiting dogs onto the test grounds.
- Participating dogs must be kept on leash except when under judgment.
- NO TRAINING is allowed on the test grounds.
- Areas are designated to air your dogs. All dog droppings must be picked up and deposited in garbage receptacles.
- Specific areas are designated to air and walk bitches in season. Please be respectful of other running dogs - make certain you air your bitch in the provided area and keep her crated when not running.
- Please pick up all garbage and deposit in garbage receptacles, *even if it is not your own.*
- Cigarette / cigar butts are NOT to be thrown on the grounds.
- If you plan to move up to the next test level, contact the test secretary first thing in the morning to fill out the form. If the move up is from WC to WCI there is an additional \$5.00 entry fee.
